

## Fees pertaining to Driving Licence and Registration of motor vehicle

**The following Fees are levied in accordance with the provision of Rule 81 of C.M.V Rules 1989.**

1	Issue of learner's licence in Form 3 for each class of vehicle	Rs. 150
2	Learner's Licence test fee or repeat test fee, as the case may be	Rs. 50
3	For test, or repeat test, as the case may be, of competence to drive (for each class of vehicle)	Rs. 300
4	Issue of a driving licence	Rs. 200
5	Issue of International Driving Permit	Rs. 1000
6	Addition of another class of vehicle to driving licence	Rs. 500

11	Issue of duplicate licence to a school or establishment for imparting instructions in driving	Rs. 5000

13	Any application for change in address or any other particulars recorded in the driving licence e.g. address etc.	Rs. 200

Note: 1. Where a Smartcard Type driving licence is issued in Form 7, an additional fee of two hundred rupees shall be levied.

2. The fees specified at serial numbers 1, 2 and 3 of the Table above shall be paid collectively at the time of submission of application for issue of learner's or driving licence or for endorsement of another class of vehicle, as the case may be.";

Note 2: In case of delay in applying for renewal of certificate of registration, an additional fee of three hundred rupees for delay of every month or part thereof in respect of motor cycles and five hundred rupees for delay of every month or part thereof in respect of other classes of non-transport vehicles shall be levied.	
5	Issue of duplicate certificate of registration	Half of the fee mentioned in serial No.4
6	Transfer of ownership	Half of the fee mentioned in serial No.4 Note: In case of delay in submission of 'No Objection Certificate', an additional fee of rupees three hundred for delay of each month or part thereof in case of motor cycles and five hundred rupees for each month of delay or part thereof for other vehicles shall be levied.

7	Change of residence	Half of the fee mentioned against serial No.4. Note: In case of delay in submission of 'No Objection Certificate', for change of residence, an additional fee of rupees three hundred for delay of each month or part thereof in case of motor cycles and five hundred rupees for each month of delay or part thereof for other vehicles shall be levied.
8	Recording alteration in the certificate of registration	Half of the fee mentioned against Serial No. 4
9	Endorsing hire purchase/lease/hypothecation agreement-

	Note: No separate fee will be levied for cancellation of lease, etc, or for issue of fresh Certificate of Registration thereafter.

	(b) Three wheeled or light motor vehicle or quadracycle	(i) Manual: Rs. 400 (ii) Automated: Rs. 600
	(c) Medium or heavy motor vehicle	(i) Manual: Rs.600 (ii) Automated: Rs.1000
11	Grant or renewal of certificate of fitness for motor vehicle	Rs. 200 Note: Additional fee of fifty rupees for each day of delay after expiry of certificate of fitness shall be levied.
12	Grant or renewal of letter of authority	Rs. 15000
13	Issue of duplicate letter of authority	Rs. 7500
14	Appeal under rule 70	Rs. 3000
15	Any application not covered under entries at Serial Nos. 1 to 14 above	Rs. 200

Note 1 : For the removal of doubts, it is hereby clarified that medium passenger motor vehicles, heavy goods vehicles, imported motor vehicles or any other vehicles not mentioned against Serial No.4 of the above Table include both transport and non-transport vehicles.

Note 2: Where the certificate of registration issued is in the form of any Smart Card Type, and additional fee of rupees two hundred shall be charged except in the case of issue of fresh certificate of registration after cancellation of hire purchase or lease or hypothecation agreement
